MIC's Mexico Customs web-based solution set can handle multiple facilities from a single hosted or licensed system. This allows for a standardized, organized and defined workflow process for your company helping you take full advantage of existing regulations while getting prepared for future changes. MIC-CUST® Mexico offers solutions for both IMMEX and Automotive Fiscal Deposit programs. The module enables the automated inventory management required by Mexican legislation (ANNEX 24 for IMMEX). The logic can also be configured to support compliance with Value Added Tax (VAT) certification (ANNEX 31).

The system allows direct electronic transfer of data to third parties (financial institutions, brokers, carriers, etc.). This prevents the re-keying of data, minimizing mistakes, reducing costs, and increasing compliance.



## **MIC Central Classification System**
